There are two rings at this show with two judges. You may ride the same test twice and will be scheduled under both judges (ie: Training Level 1 in Ring A and Training Level 1 in Ring B) Please write the test down TWICE if you wish to ride it twice.

Summit County 4Hers: To earn county representative awards in dressage you are required to enter this show. You may qualify according to Ohio 4H rules but must enter this show to receive official county awards

I am fully aware and acknowledge that horse sports and competition involves inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("harm). I agree to hold harmless and release the competition, Summit County 4H Saddle Horse Association, its members and volunteers, (collectively the "Competition Management") from all claims of money damages or otherwise for any harm to me or my horse and for any harm or any nature caused by me or my horse to others, even if the harm arises or results directly from the Competition Management. I agree to expressly assume all risks of harm to me or my horse, including harm resulting from the Competition Management. I agree to indemnify (that is, to pay any losses, damages, or costs incurred by), the Competition Management and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for any harm caused by me or my horse while at the event. I agree to follow all rules of the competition, as set forth in 4H Uniform Rules and Summit County 4H Saddle Horse Association rules. Furthermore, even though approved helmets are required and other protective gear is recommended, the Competition Management issues a warning that not all injuries can be prevented with proper use of protective equipment. If I am the parent/guardian of a minor exhibitor, I consent to the child's participation and above provisions and agree to assume all obligations of this Release on the child's behalf. I agree that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Competition Management.
