PAS Highlights (Summit County)

- Specify on your application which show(s) you are attending.
- All classes will be offered as long as there is at least 1 entry.
- You may only compete at a **maximum** of 2 PAS shows (regardless of county) **or** 1 double-judged PAS show.
- State Participants need to qualify in **2** classes to compete at Ohio State Fair Junior Horse Show.
- You can compete in up to 4 classes at State Fair.
- You can sign up for different classes at each PAS show.
- At PAS, you may **not** compete in both:
 - Ranch Horse Pleasure and Western Pleasure at the same show.
 - Trail and Trail-In-Hand at the same show.
- At State Fair you may **not** compete in both:
 - Intermediate and Advanced Equitation over Fences
 - Low and Regular Hunter over Fences.
- If you State Qualify at a Summit County PAS Show and you intend to go to the State Fair Youth Show, a Parent or Adult representative must accompany you when signing up for State Fair.
- If you plan to compete outside of Summit County, you need to contact Jackie Krieger (Summit Co. Extension Officer) for information and an Out-Of-County form. The form requires signatures from both Ms. Krieger and the County Representative where you plan to compete.
- If you qualify in another county, you will owe Summit County 4H Saddle Horse Association a \$40 fee, which will go towards a Stall Sign and Belt Buckle (If eligible for Buckle).

* **Summit County Participants: In Order to Receive a Buckle, You Must Compete at the Ohio State Fair!**
